

# **Gloster Trial**

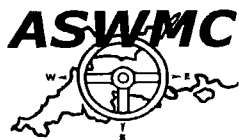
## **Sunday 3rd December 2017.**

The **750 Motor club** will organise The Gloster Trial on Sunday 3rd December 2017. The event is being run as National B and Clubmans

### **Supplementary Regulations.**

- 1) To be held at, **Frocester, Nr Stroud. Map 163/793019, opp Hill Fm, Post Code GL10 3TP.**
- 2) The event will be held under the General Regulations of the Motor Sports Association Ltd, incorporating the provisions of the International Sporting Code of the FIA, these S.R's and any other written instructions the promoting club may issue.
- 3) M.S.A. Permit No      National B                      Clubmans
- 4) The event is open to members of MSA Registered Motor clubs as follows, BTRDA, 750MC, Bristol MC, Camel Vale MC, Coventry and Warks MC, Hagley MC, Launceston and District MC, MAC, NPTCC, Peterborough MC, Ross and District MC, Southsea MC, Sporting trial.com, Stroud and District MC, Yorkshire MC,
- 5) To enter the National B entrants must hold a BTRDA membership and relevant MSA competition licence and to entry the Clubmans must have a current membership card for an invited club.
- 6) This event is being run as part of **the BTRDA, MSA, 750MC and ASWMC championships.**
- 7) Public roads will not be used to link sections. There will be at least 1 round of 8 sections, all on private land.
- 8) **Entries:** The entry list opens on receipt of these regulations and closes on **27<sup>th</sup> November 2017 18:00 hrs** and entries must be made on the official entry form accompanied by the correct fee. Post-dated cheques will not be accepted. All entries will be acknowledged by the issue of **Final Instructions after the closing date, by email.** The maximum number of entrants is **43** and the minimum is **26.** (Subject to organisers discretion).  
**Entry fee is £40;** no late entries will be accepted.
- 9) The event will be run with all classes running mixed at the same time.

- 12) **Signing on** will commence at **8.30 a.m.** on site. **All Drivers must produce a valid Club membership card and an MSA competition license for 2017 for National B.**

- 13) Any competitor not signed on by 10.00 a.m. may be excluded.
- 14) Passengers need to hold membership of an invited MSA registered Motor club for National B entries.
- 15) **Scrutineering and eligibility:** Scrutineering will commence at 8.30 a.m. Individual scrutineering times will not be allocated. All cars must comply with the M.S.A. Technical regulations for the National Trials Car Formula. National B entrants should produce a logbook for their car at scrutineering.
- 16) All Championship contending vehicles must use tyres as listed in the current MSA / BTRDA regulations. : Clubman's (non championship) may use any tyre listed in the Blue Book regulations.
- 17) **Tyre Pressures:** The minimum tyre pressure will be set on the day and competitors are required to present their car at scrutineering with a minimum of **5 p.s.i.** in the driven wheels. This will allow for calibration of gauges and the Competitors will be advised as early as possible the minimum tyre pressures that will apply. Any modification to this minimum tyre pressure for the second/ third round will be posted at control and signed for.
- 18) The first round will commence at **10.00 a.m.** prompt. Practising will not be permitted.
- 19) Competitors are requested to walk the sections before attempting them.
- 20) Competitors will be identified by numbers issued at signing on. Competitors will start at a different hill on each round and these arrangements will be advised at signing on. Running order will be decided by ballot after the closing date.
- 21) Marshals on each observed section shall be deemed Judges of Fact in connection with Section T 7.1. All other GR's of the M.S.A. apply as written.
- 22) Toilets will be on site & a paramedic will be in attendance.
- 23) Provisional results will be announced as soon as practicable after the event has finished.
- 24) Awards will be presented

**DECLARATION I Declare That**

1 I have been given the opportunity to read the General Regulations of the Motor Sports Association and the Supplementary Regulations for this event and agree to be bound by them. I declare that I am physically and mentally fit to take part in the event and I am competent to do so. I acknowledge that I understand the nature and type of event and the potential risk inherent with motor sport and agree to accept that risk.

2 To the best of my belief the driver possesses the standard of competence necessary for an event to which this entry relates and that the vehicle entered is suitable and roadworthy for the event having regard to the course and the speeds which will be reached.

3 I understand that motorsport can be dangerous and accidents causing death, injury, disability and property Damage can and do happen. I understand that these risks may give rise to my suffering personal injury or other loss and I acknowledge and accept these risks. In consideration of the acceptance of this entry I agree that neither any one of or any combination of the MSA and its associated clubs, the organisers, the track owners or other occupiers, the promoters and their respective officers, servants, representatives and agents (the "Parties") shall have any liability for loss or damage which may be sustained or incurred by me as a result of participation in the event. Including but not limited to damage to property, economic loss, consequential loss or financial loss howsoever caused.

Nothing in this clause is intended to or shall be deemed to exclude or limit liability for death or personal injury. To the fullest extent permitted by law I agree to indemnify and hold harmless each of the Parties in respect of any loss or damage whatsoever and howsoever arising from my participation in this event.

4 If I am the Parent/Guardian/Guarantor of the driver I understand that I shall have the right to be present at any procedure being carried out under the Supplementary Regulations issued for this event and the General Regulations of the MSA.
